#### Q1 : What is the claim limit for HRDC for external trainings & Team Buildings

Answer :

The current allowance structure from HRDC is

RM150/day/pax - Equals or below 100 km from client office to training venue RM400/day/pax - Equals or **above**100 km from client office to training venue For more information please refer to the allowance benchmark

#### Q2 : What is the difference between Levy & Grant Balance In HRDC

Answer :

i) Levy Balance refers to the actual levy amount in the employer's account which is contribution minus reimbursement.

ii) Grant Balance is your projection of your last levy payment 6 months ahead plus levy balance and minus approved requested grant amount.

### Q3 : What is the general procedure for a Training & Team Building inquiry

Answer :

ii) Once you received the (i)Training invoice , (ii)Accomodation / Meal / Hall rental invoice and (iii) Transportation invoice form the related vendors, kindly proceed to the HRDC E tris System for Grant application HRD-Corp Claimable-Courses Grant-Helper (1) (1).pdf

#### Q4 : What is the Training and Activities offered by your firm?

### Q5 : What Should i do after submitted the grant application from HRDC

Answer :

Usually HRDC will take up to 5 Working days to review the application, once approved you may need to make payment for Resort , Hotels , Meal & Transport vendor in order to secure the bookings

## <u>Q6 : Do I need to pay any deposit to the training provider if under HRDF</u> <u>Claimable training?</u>

Answer :

No, you do not need to pay any deposits or bookings for the training fee. You only need to pay for the Resort , Hotels , Meal & Transport (Claim back from HRDC after the trainings)

### Q7 : What should I do after the training?

Answer :

You may need to sign and submit the HRDC T3 Attendance form & HRDC JD14 (Declaration form) to the training provider and wait for training confirmation. Once confirmed you can submit your claim in the HRDC Etris system for the training expenses (Resort, Hotels, Meal & Transport) ■ Claim-Submission\_SBLKHAS\_EMPLOYER\_HRDCORP-Claim-Helper-3.pdf

### <u>Q8 : What is the maximum duration for an employer to submit the training</u> <u>expenses claim?</u>

Answer :

The maximum duration for HRDC Claim submission is 6 months after the event.

### <u>Q9 : How long does HRDC process my training expense claim after I submit it to</u> Etris?

#### Answer :

Usually HRDC will take 5 Working days to verify the claim, once complete you will receive an official email notify and receive the reimbursement within another 5 working days (into your company registered bank account)

## Q10 : What should I do if my Levy balance does not enough to cover all the training expenses?

Answer :

You only can claim the maximum of your Levy account balance. In case your levy balance is not enough you might need to self pay the additional amount.

Answer :

Yes, you can modify or withdraw your grant application form the HRDC Etris system before the trainings (Subject to mutual agreement)

#### Q12 : Do I need to pay any penalty if I cancel the training?

Answer :

No, you do not need to pay any penalty to the training provider.

#### Q13 : Can i Claim more than what HRDC approved amount?

Answer :

No, you cannot claim more than the HRDC approved amount. HRDF will reimburse according to your actual receipt that you submit after the event.
